

# Cross-border Airline Shopping Why is Canada Losing Out?

### A snapshot of the Canadian airline industry

- Industry represents \$35 B in GDP annually
- Total employment impact of approx. 400,000
- 150,000 are direct employment
- 110.9 million domestic and international trips in 2012
- 23.5 million Can-U.S. trips

#### Recent CBoC research on Can-U.S. air travel

- "Why More Canadians are Choosing Cross Border Airports"
- •Each year, up to 5 million Canadians cross the U.S. border on land to fly from U.S. airports, largely to U.S. destinations
- Analysis focused on Vancouver (YVR), Toronto (YYZ) and Montreal (YUL) and their U.S. counterparts
- A "perfect storm" of factors fees and taxes the largest part, but not the only part





share of contribution to Canadian/U.S. price differentials, per cent






### Example of Taxes and Fees Applied to Base Fare to US Destinations (One-Way), \$

	From Canada	From US	Notes:
Base fare	200.00	140.00	Assuming base fare to be 30 per cent lower based on air carrier cost structure comparison.
AIF/PFC	20.00	9.20	AIFs from Canadian airports are typically \$15 to \$25. Service from the cross-border airports are typically connecting flights, so two PFCs of up to \$4.60 each apply.
Security	12.10	5.12	Security fee in the US is \$2.56 per flight segment, up to a maximum of \$5.12.
US Federal Excise Tax	17.08	10.50	Fixed charges apply to flights with non-domestic origin. 7.5 per cent tax applied to domestic flights.

### Some economic impacts

- "Cross-border airline shopping": we estimate annual net loss of 2 million trips (since some would not have travelled otherwise)
- •This represents 2 per cent of total Cdn airline trips small but material
- •A 1 per cent reduction in revenues = 4000 Cdn jobs lost, of which 1500 are direct
- Price elasticity of cross-border airline travel is 1 meaning a 1 per cent reduction in price will increase revenues by 1 per cent

#### The Bottom Line

- No single factor explains the Can-US price differential
- •No quick fix fees and taxes are only part of the problem
- Hard to change the fundamental economics of U.S. vs. Canadian air carriers – aircraft financing, labour costs, productivity
- But without a more level playing field, the price gap will remain and consumers will react accordingly
